3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Frank Moore Wild  
5 Steelhead Special Management Area Designation Act”.

6 **SEC. 2. FINDINGS.**

7 Congress finds that—

8 (1) Frank Moore has committed his life to fam-  
9 ily, friends, his country, and fly fishing;

10 (2) Frank Moore is a World War II veteran  
11 who stormed the beaches of Normandy along with  
12 150,000 troops during the D-Day Allied invasion

1 and was awarded the Chevalier of the French Legion  
2 of Honor for his bravery;

3 (3) Frank Moore returned home after the war,  
4 started a family, and pursued his passion of fishing  
5 on the winding rivers in Oregon;

6 (4) as the proprietor of the Steamboat Inn  
7 along the North Umpqua River in Oregon for nearly  
8 20 years, Frank Moore, along with his wife Jeanne,  
9 shared his love of fishing, the flowing river, and the  
10 great outdoors, with visitors from all over the United  
11 States and the world;

12 (5) Frank Moore has spent most of his life fish-  
13 ing the vast rivers of Oregon, during which time he  
14 has contributed significantly to efforts to conserve  
15 fish habitats and protect river health, including serv-  
16 ing on the State of Oregon Fish and Wildlife Com-  
17 mission;

18 (6) Frank Moore has been recognized for his  
19 conservation work with the National Wildlife Fed-  
20 eration Conservationist of the Year award, the Wild  
21 Steelhead Coalition Conservation Award, and his  
22 2010 induction into the Fresh Water Fishing Hall  
23 of Fame; and

24 (7) in honor of the many accomplishments of  
25 Frank Moore, both on and off the river, approxi-

1           mately 99,653 acres of Forest Service land in the  
2           State of Oregon should be designated as the “Frank  
3           Moore Wild Steelhead Special Management Area”.

4 **SEC. 3. DEFINITIONS.**

5           In this Act:

6           (1) **MAP.**—The term “Map” means the map en-  
7           titled “Frank Moore Wild Steelhead Special Man-  
8           agement Area Designation Act” and dated June 23,  
9           2016.

10           (2) **SECRETARY.**—The term “Secretary” means  
11           the Secretary of Agriculture, acting through the  
12           Chief of the Forest Service.

13           (3) **SPECIAL MANAGEMENT AREA.**—The term  
14           “Special Management Area” means the Frank  
15           Moore Wild Steelhead Special Management Area  
16           designated by section 4(a).

17           (4) **STATE.**—The term “State” means the State  
18           of Oregon.

19 **SEC. 4. FRANK MOORE WILD STEELHEAD SPECIAL MAN-**  
20 **AGEMENT AREA, OREGON.**

21           (a) **DESIGNATION.**—The approximately 99,653 acres  
22           of Forest Service land in the State, as generally depicted  
23           on the Map, is designated as the “Frank Moore Wild  
24           Steelhead Special Management Area”.

25           (b) **MAP; LEGAL DESCRIPTION.**—

1           (1) IN GENERAL.—As soon as practicable after  
2 the date of enactment of this Act, the Secretary  
3 shall prepare a map and legal description of the Spe-  
4 cial Management Area.

5           (2) FORCE OF LAW.—The map and legal de-  
6 scription prepared under paragraph (1) shall have  
7 the same force and effect as if included in this Act,  
8 except that the Secretary may correct clerical and  
9 typographical errors in the map and legal descrip-  
10 tion.

11           (3) AVAILABILITY.—The map and legal descrip-  
12 tion prepared under paragraph (1) shall be on file  
13 and available for public inspection in the appropriate  
14 offices of the Forest Service.

15           (c) ADMINISTRATION.—Subject to valid existing  
16 rights, the Special Management Area shall be adminis-  
17 tered by the Secretary—

18           (1) in accordance with all laws (including regu-  
19 lations) applicable to the National Forest System;  
20 and

21           (2) in a manner that—

22           (A) conserves and enhances the natural  
23 character, scientific use, and the botanical, rec-  
24 reational, ecological, fish and wildlife, scenic,

1 drinking water, and cultural values of the Spe-  
2 cial Management Area;

3 (B) maintains and seeks to enhance the  
4 wild salmonid habitat of the Special Manage-  
5 ment Area;

6 (C) maintains or enhances the watershed  
7 as a thermal refuge for wild salmonids; and

8 (D) preserves opportunities for recreation,  
9 including primitive recreation.

10 (d) FISH AND WILDLIFE.—Nothing in this section  
11 affects the jurisdiction or responsibilities of the State with  
12 respect to fish and wildlife in the State.

13 (e) ADJACENT MANAGEMENT.—Nothing in this sec-  
14 tion—

15 (1) creates any protective perimeter or buffer  
16 zone around the Special Management Area; or

17 (2) modifies the applicable travel management  
18 plan for the Special Management Area.

19 (f) WILDFIRE MANAGEMENT.—Nothing in this sec-  
20 tion prohibits the Secretary, in cooperation with other  
21 Federal, State, and local agencies, as appropriate, from  
22 conducting wildland fire operations in the Special Manage-  
23 ment Area, consistent with the purposes of this Act, in-  
24 cluding the use of aircraft, machinery, mechanized equip-  
25 ment, fire breaks, backfires, and retardant.

1           (g) VEGETATION MANAGEMENT.—Nothing in this  
2 section prohibits the Secretary from conducting vegetation  
3 management projects within the Special Management  
4 Area in a manner consistent with—

5           (1) the purposes described in subsection (c);

6           and

7           (2) the applicable forest plan.

8           (h) PROTECTION OF TRIBAL RIGHTS.—Nothing in  
9 this section diminishes any treaty rights of an Indian  
10 tribe.

11          (i) WITHDRAWAL.—Subject to valid existing rights,  
12 the Federal land within the boundaries of the Special  
13 Management Area river segments designated by sub-  
14 section (a) is withdrawn from all forms of—

15           (1) entry, appropriation, or disposal under the  
16 public land laws;

17           (2) location, entry, and patent under the mining  
18 laws; and

19           (3) disposition under all laws relating to min-  
20 eral and geothermal leasing or mineral materials.
